# Spring Tour - SIA Conference, Indiana, Ohio and Michigan

## 28<sup>th</sup> May – 6<sup>th</sup> / 7<sup>th</sup> June 2012

#### An unmissable opportunity to see the industrial history of the mid-west.

The trip is a little longer than usual for an AIA tour but to make the longer air journey worthwhile it makes sense to spend more time at our destination.

Before the conference the tour will include :

- A unique tour of Madison, Indiana, a beautiful and historic small industrial city, boasting one of America's largest National Historic Landmark Districts set in the scenic Ohio River Valley with many fascinating sites. We will visit:
  - The Schroeder Saddletree Factory, the only surviving saddletree manufactory in the US. This 19thC gem is packed with belt powered machinery which produced 500,000 wooden frames for riding saddles and was the subject of a project which has won several national and state preservation awards
  - The steepest standard gauge line haul track in the US, part of the first railroad west of the Allegheny mountains. The track was installed in a cutting through 400 foot high bluffs in the late 1830s and rises over 413 foot in 7,012 feet
  - The Madison-Milton Bridge of 1929 which connects Madison, IN with Milton, KY spanning the Ohio River and is over 3,180 feet long. A \$110 million bridge replacement project for this historic span is underway which will feature a "bridge slide" method to install the new span on top of reinforced existing piers. The engineering company believes this will be the biggest "bridge slide" ever attempted in the Western Hemisphere and we plan to include a specially organised talk about the project by the chief engineer
- A specially organised visit to Columbus, Indiana, a surprising community known around the world for its collection of work by renowned architects and landscape architects ranked amongst the best in the US for architectural innovation and design by the American Institute of Architects. We also plan to include:
  - The Cummins high horsepower plant (where they produce their new 4,000 hp diesel engine)
  - The early 20<sup>th</sup> C Medora Brick Kilns once producing 54,000 hand-made bricks per day
  - An historic hand-tool manufacturer, a 19th C mill and a look at some unique historic bridges

The annual conference of the Society for Industrial Archaeology is to be held in Cincinnati this year and will be made up of :

- A day of excursions organised by the SIA to sites including: the Old River Pumping Station (a mecca for stationary steam enthusiasts), a foundry and paper making
- An evening film festival at Cincinnati's grandiose Masonic Center
- A full day of research paper presentations
- An evening banquet at the Cincinnati Historical Museum in the art deco splendour of the Union Terminal
- A Sunday morning walking tour in Cincinnati

After the conference we will take in :

- The USAF aviation museum at Dayton, Ohio the largest in the world!
- A specially arranged guided tour of Detroit by Dr Charles Hyde, academic, author and historian of the automotive industry who will show us some of the former glory of this great industrial city. The tour will include:
  - The Near East Riverfront, the historic site of much of Detroit's earliest industries including shipbuilding, marine engine manufacturing and pharmaceuticals
  - The Piquette plant (1904 10) birthplace of the model 'T'
  - The derelict Packard complex and the Ford Highland Park plant site of the first moving assembly line these two being amongst architect Albert Kahn's earliest industrial buildings
- A day at the Henry Ford Museum including "Driving America", just opened, a completely new launch of their automotive exhibits. Optionally members can also include the Rouge Factory Tour to see the truck assembly plant and other attractions.
- An optional extra day at Dearborn where members can visit Greenfield Village a huge collection of historic artefacts and buildings collected by Henry Ford including examples of Newcomen and Watt engines collected from the UK, an operating steam-powered rail line and an 1800s small-town train depot, paired with the chance to investigate the only working late 19th-century roundhouse in the Midwest.

I am indebted to Ron Petrie and other members of the SIA who are giving a great deal of help with planning this itinerary and who are looking forward with enthusiasm to welcoming an AIA group at their conference.

The tour is open to non AIA members. Our itinerary is as follows :

#### ACCOMMODATION

The tour uses 4 star hotels in down town locations (except at Cincinnati airport) which have their own restaurants but are also conveniently located for other bars and restaurants within walking distance. All have internet access and lifts to upper floors. All rooms have two "Queen" size beds (5ft), en-suite facilities and TV

#### DINING

Breakfast is included with all overnight stays. A light lunch is included on 29<sup>th</sup>, 30<sup>th</sup>, 31<sup>st</sup> May, 1<sup>st</sup>, 2<sup>nd</sup> and 5<sup>th</sup> June, this may be a 'box lunch' on some days. An evening meal is included on 31<sup>st</sup> May.

#### TRANSPORT

The tour starts in Cincinnati, Ohio and ends in Detroit, Michigan.

We leave you to make your own travel arrangements to suit your own convenience and use of alternative departure points. Cincinnati North Kentucky Airport is a regional hub and there are frequent flights by multiple airlines to there from the UK via one other place, but none direct. Delta operate a direct evening flight from Detroit to London Heathrow, many other airlines operate indirect flights. Travel during the tour will be by luxury, air-conditioned coach.

#### COST

The cost of the main tour includes 9 nights' bed and breakfast accommodation (which includes the conference accommodation); meals as indicated above; all entrance fees; all coach travel; guiding and tour management while in the US; research for the visit and tour notes.

Costs are dependent on the number travelling. There is a minimum of 12 people but we are confident that we will reach more than the minimum number as booking is also being opened to members of the SIA.

The cost for the tour will be between \$1395 and a maximum of \$1815 per person sharing with a \$615 single supplement. Those who wish to share are responsible for finding the person to share with.

### **PASSPORTS, VISAS & IMMIGRATION**

We anticipate that most people holding UK passports will be eligible to enter the United State under the Visa Waiver Program (VWP). However you must visit the website of the US Embassy in London http://london.usembassy.gov/vwp.html (or your home country) in good time before you travel to ensure that you are eligible under the program and then you must proceed to register under the Electronic System for Travel Authorization (ESTA) https://esta.cbp.dhs.gov/esta/

If you are not eligible under the VWP then you must obtain a visa from the Embassy.

On arrival at US immigration you should be carrying a return ticket or an e-ticket and your itinerary to show that you do not intend to remain in the US.

Regular visitors to the US will know that immigration into the US can be a lengthy business, often involving standing in line for an extended period. When booking an onward flight from the point of immigration (usually the first place you touch down on US soil) you must leave sufficient time between flights – a minimum of 2 hours, 3 is better.

You should not book any travel arrangements until you hear positive confirmation from us that the tour will proceed, this will be by 31<sup>st</sup> March at the latest.

- 1. No variation can be accepted unless made in writing and signed by the Company.
- 2. Bookings can only be made definite when the completed booking form plus the deposit specified on the booking form is received and accepted in writing by the Company. The deposit is not refundable.
- 3. The balance of the tour price must be received by the Company not later than 8 weeks before the first day of the tour or as specified in the booking arrangements failing which the booking may be cancelled and cancellation charges (equivalent to the amount of deposit) levied.
- 4. In the event that the booking is made less than 8 weeks before the first day of the tour then the full amount of the tour price will need to be paid immediately.
- 5. In the event that you wish to cancel your booking, you must notify the Company in writing. If the notification of cancellation is received by the Company more than 8 weeks before the first day of the tour then only the deposit will be forfeit. If the notice is received less than 8 weeks before the first day of the tour the following charges will apply: 6 to 8 weeks, 50% of the tour price; 4 to 6 weeks, 75% of the tour price; 4 weeks and under, 100% of the tour price. No refund at all will be given for any cancellation on or after the first day of the tour or for any meals, trips or other facilities not used or taken.
- 6. The Company will make every effort to operate the tour as confirmed to you.
